- Bitches in season will run in order. They should be crated away from trial arenas when not competing. Please inform the trial secretary.
- All dogs must be on leash when not competing.

- Trial committee will determine run order prior to the trial.
- Entry fees will only be refunded if request is received before entry closing date. Checks will be shredded.
